1. This Auto Cycle Rental Agreement is made and entered into on the between:

Identification of Rental Vehicle

2. Owner hereby agrees to rent to Renter, an auto cycle identified as follows:
 - a. 2021 Slingshot- S with Auto Drive Color white, vin:57xaathd3m8146529

Rental Term

3. The term of this Auto Cycle Rental Agreement runs from _____ - to _____ - ____ upon completion of all terms of this agreement by both Parties.

Scope of Use

- 5. Renter will use the Rented Vehicle only for personal or routine business use and operate the Rented Vehicle only on properly maintained roads and parking lots.
- 6. Renter will comply with all applicable laws relating to holding licensure to operate the vehicle and pertaining to operation of motor vehicles.
- 7. Renter will not sublease the Rental Vehicle or use it as a vehicle for hire.
- 8. Renter will not take the vehicle location limit.
- 9. Renter will not allow any other person to operate the Rented Vehicle unless identified here:
 - a. Primary Vehicle Operator: [DRIVERS LICENSE NUMBER _____]
 - b. Additional Vehicle Operator: [DRIVERS LICENSE NUMBER _____]

Mileage

- 10. Mileage of the Rental Vehicle is mileage at the time of commencement of this Auto Cycle Agreement. Mileage on the vehicle will be Unlimited.
- 11. **Rental Fees**
- 12. Renter will pay to Owner rental fees for use of the Rental Vehicle as follows:
 - a. **\$200 Plus Tax Daily-24 Hours-Gas Not Included with Price**
 - b. **[FUEL] Additional fee of \$39 if close to empty, \$21 if close to half.**
 - c. **Normal hourly rental \$30.00 an hour.**
 - d. **Driver must be 25 years or older.**
 - e. **Security deposit of an additional \$250, refunded upon return of the vehicle.**

Security Deposit

- 13. Renter will be required to provide a security deposit to Owner in the amount of dollars (\$250.00) to be used in the event of loss or damage to the Rental Vehicle during the term of this agreement. Owner may, in lieu of collection of a security deposit, place a hold on a credit card in the same amount. In the event of damage to the Rental Vehicle, Owner will apply this Security Deposit to defray the costs of necessary repairs or replacement. If the cost for repair or replacement of damage to the Rental Vehicle exceeds the amount of the Security Deposit, Renter will be responsible for payment to the Owner of the balance of this cost.
- 14. Renter must agree to pay a total of \$250.00 for a lost Auto Cycle key replacement.

Insurance

- 15. Renter must provide to owner with proof of insurance that would cover damage to the Auto Cycle at the time this Auto Cycle Rental Agreement is signed, as well as personal injury to the Renter, passengers in the Rented Auto cycle, and other persons or property.
- 16. If the Auto Cycle is damaged or destroyed while it is in the possession of Renter, Renter agrees to pay any required insurance deductible and also assign all rights to collect insurance proceeds to Owner.

Indemnification

- 17. Renter agrees to indemnify, defend, and hold harmless the Owner for any loss, damage, or legal actions against Owner as a result of Renter’s operation or use of the Rented Auto Cycle during the term of this Auto Cycle Agreement. This includes any attorney fees necessarily incurred for these purposes.

- 18. Renter will also pay for any parking tickets, moving violations, or other citations received while in possession of the Rented Auto Cycle.
- 19. Renter agrees to return the auto cycle no later than 30 minutes late at the point of pickup area unless otherwise requested.

Representations and Warranties

- 20. Owner represents and warrants that to Owner’s knowledge; the Rental Vehicle is in good condition and is safe for ordinary operation of the auto cycle vehicle.
- 21. Renter represents and warrants that Renter is legally entitled to operate an auto cycle under the laws of this jurisdiction and will not operate it in violation of any laws, or in any negligent or illegal manner.
- 22. Renter has been given an opportunity to examine the auto cycle in advance of taking possession of it, and upon such inspection, is not aware of any damage existing on the vehicle other than that notated by separate Existing Damage document.

Jurisdiction and Venue

- 23. In the event of any dispute over this Agreement, this Auto Cycle-Sling Shot Rental Agreement will be interpreted by the laws of United States, Hillsborough County, and any lawsuit or arbitration must be brought in the corresponding region of Hillsborough County. If any portion of this Agreement is found to be unenforceable by a court of competent jurisdiction, the remainder of the Agreement would still have full force and effect.

Entire Agreement

- 24. This Auto Cycle Agreement constitutes the entire agreement between the Parties with respect to this rental arrangement. No modification to this Agreement can be made unless in writing signed by both parties. Any notice required to be given to the other party will be made to the contact information below.
